**SPECIAL INSTRUCTIONS FOR PARTICIPANTS IN THE GE HEALTHCARE RETIREMENT SAVINGS PLAN (RSP)**

In accordance with the terms of the RSP, any GE HealthCare shares allocable to your RSP account as of March 27, 2023 will be voted by the trustee of the RSP trust, Fidelity Management Trust Company, as you instruct. You may give instructions via telephone or the internet or by mailing the proxy form. If your valid proxy form is received by May 18, 2023, and it does not specify a choice, the independent fiduciary of the GE HealthCare Stock Fund in the RSP, State Street Global Advisors Trust Company (SSGA) will vote the shares. You may revoke a previously delivered proxy by delivering a subsequent proxy or by notifying the inspectors of election in writing of such revocation on or before 11:59 p.m. Eastern Time on May 18, 2023. If your proxy form is not received by May 18, 2023, and you did not submit a vote via telephone or the internet by that date, shares allocable to your RSP account will be voted by SSGA.
